Generally there are four to six pre-marital counseling sessions over a period of six to eight weeks. During these sessions serious consideration is given to the practical and Biblical aspects of marriage.

Generally, after the first or second meeting with the prospective bride and groom it will be decided if the minister will agree to conduct the wedding. Spiritual and practical matters are both a part of the decision. If a minister other than one on staff at Springboro Christian Church is being requested to conduct the wedding, the prospective bride and groom will consult with that minister concerning pre-marital counseling, etc.

After completing this form, return it (along with the prospective groom's completed form) to the Springboro Christian Church. Your request will be given attention and you should be contacted within a week after this request is received. If you are not contacted within a week, please contact the church office.
